

PRIVACY STATEMENT

Stichting Go Short – International Short Film Festival Nijmegen (hereinafter referred to as ‘Go Short’) respects your privacy. This statement describes how Go Short handles your data.

Use of Personal Data Provided by You

Go Short only uses and processes personal data when it is necessary to achieve the purpose for which they are requested and/or when you have explicitly given your consent:

- If you submit a film for programming purposes, Go Short processes your data to fulfill that request and to maintain contact regarding your submission.
- If you register online for an event or apply for accreditation, Go Short processes your data to fulfill that request and to maintain contact regarding your application and the execution of the agreement.
- If you purchase a ticket or pass online from Go Short, we use your data solely to contact you about the respective activity and the execution of the agreement or to inform you about similar products and services from Go Short.
- If you purchase a ticket or pass online for a Go Short event via the Stichting LUX ticketing system, Go Short can access this data and uses it solely to contact you about the respective activity and the execution of the agreement or to inform you about similar products and services from Go Short.
- If you purchase a ticket or pass online for a Go Short event via the Ikbenaanwezig ticketing system, Go Short can access this data and uses it solely to contact you about the respective activity and the execution of the agreement or to inform you about similar products and services from Go Short.
- If you submit a job application, Go Short processes your data within the scope of the recruitment process.

There are exceptions where Go Short processes your data without your explicit consent, but where a legitimate interest applies:

- If you are involved with Go Short as a participant, partner, employee, or volunteer, Go Short retains your data to be able to contact you for potential collaboration in the future.
- If you attend a Go Short event, photos and videos may be taken in which you appear. These images may be used for reporting and promotional purposes.
- Go Short does not retain personal data longer than necessary for the purpose of data processing or as required by the Dutch Archives Act. Additionally, Go Short ensures appropriate security of personal data.

Recipients of Your Data

Your personal data may be shared by Go Short with the following categories of recipients:

- Those responsible for or necessarily involved in executing the agreement;
- Those responsible for or necessarily involved in communication with you;
- Others, if you have given unambiguous consent;
- Others, if the data processing is necessary to comply with a legal obligation;
- Others, if the data is (exclusively) processed for statistical or historical purposes.

Transfer to Countries Outside the EU/EEA

Your personal data will not be transferred to countries outside the EU or EEA, except for MailChimp, based in the United States, if you subscribe to one of our newsletters. MailChimp has an EU-approved model contract that ensures an adequate level of protection for your personal data, as recognized by the European Commission.

External Links to Other Websites

The Go Short website provides the option to click through to websites of other organizations. Go Short is not responsible for how those other websites handle personal data. We advise you to carefully read the privacy policies or statements of these external websites, as their terms may differ from those applied by Go Short.

Google Analytics

Go Short uses Google Analytics to track online statistics and improve the website. The collected data is transferred to Google servers in the United States and stored indefinitely.

Cookies

Go Short uses cookies to enhance the user experience on its website. Cookies are small pieces of text-based information that are sent to your browser when visiting websites or applications and are stored on your computer, tablet, or mobile phone.

If you wish to block cookies, you can adjust your browser settings accordingly. Each browser has different settings for this, and most browsers provide explanations on how to do so in their help function. However, blocking cookies may cause certain functionalities on our website to work less effectively.
